## The Motion passed.

David Flinn with Ferris and Flinn Engineering addressed the Board concerning the requirement for a pipeline and easement in connection with the Palm groves Subdivision. Mr. Flinn was requesting that the Board alter the policy that required the developer to provide water to the adjacent property when access to water is cut off by the development. There was no action taken.

Alfonso Gonzales presented a proposal for engineering services in the amount of \$14,400.00. The proposal laid out a plan to study the ability of the District to deliver sufficient water to meet the future design of both of the Harlingen Waters Works treatment plants. After a short discussion a motion was made by Leonard Simmons and seconded by Levi Burns to approve the proposal. The motion passed.

A motion was made by Leonard Simmons and second by Keith Adams to open a Public Hearing on exclusion of land in accordance with Chapter 49, Subchapter J-1, Texas Water Code. The motion passed. Being no public comment the hearing closed.

A motion was made by Levi Burns and seconded by Rick Guerrero to pass a resolution and exclude the following properties in accordance with Chapter 49, Subchapter J-1, Texas Water Code. The motion passed.

## RESOLUTION OF THE HARLINGEN IRRIGATION DISTRICT CAMERON COUNTY NO.1 BOARD OF DIRECTORS September 14, 2022

A regular meeting of the Board of Directors of HARLINGEN IRRIGATION DISTRICT CAMERON COUNTY NO.1 was convened on September 14, 2022 at 9:00 a.m. at the office of the District in Harlingen, Cameron County, Texas, and the roll was called off the duly constituted members of said Board, to-wit Sam Morrow, Leonard Simmons, and Jose Ricardo Guerrero, Keith Adams and Levi Burns were present, constituting a quorum. At said meeting, the Board approved the following by unanimous vote:

## RESOLUTION AND ORDER

**WHEREAS**, all of the property described below is urban property within the meaning of applicable law; and.

**WHEREAS**, the District has no outstanding bonded indebtedness or indebtedness in connection with a loan from an agency of the United States and has authority under Texas Water Code sec. 49.3182 to hold a hearing and exclude the urban property; and

WHEREAS, a Hearing was duly ordered and properly noticed to determine whether or not all of the urban property described below or what part thereof, currently lying within the boundaries of HARLINGEN IRRIGATION DISTRICT CAMERON COUNTY NO.1 in Cameron County, Texas, shall be excluded from the District's boundaries; and,

**WHEREAS**, a Hearing was held at the offices of the District on the7th day of September 2022, at 9:00 a.m. where all interested persons had an opportunity to appear and be heard;

**NOW, THEREFORE, BE IT RESOLVED AND ORDERED** that the Board of Directors hereby finds that as to all of the property described below, the owners of a majority in acreage of the urban property do not desire irrigation of that property, and that the urban property is not used or intended to be used for agricultural purposes.

IT IS FURTHER RESOLVED that the Board of Directors hereby excludes the property listed below.

If any canals, ditches, pipelines, pumps, or other facilities of the District are located on land excluded under this Resolution, the exclusion does not affect or interfere with any of the District's rights to maintain and continue operation of the facilities as located to service land remaining in the District.

The Secretary of the Board is hereby directed to record a copy of this resolution in the deed records of Cameron County.

The manager presented information regarding the 2023 service rates, water rates and flat rate assessments charged by the District. After a short discussion a motion was made by Leonard Simmons and seconded by Levi Burns to no longer offer the 3% early payment incentive and increase the service rates in 2023 by 5% over the 2022 rates and to set the water delivery rate for 2023 at: \$11.00 per acre, to set the 2023 flat rate assessment in the Harlingen area to \$24.00 for the first acre and \$15.44 for each additional acre and the flat rate assessment for the Adams Gardens area to \$33.08 per acre. The motion passed.

The manager presented the 2023 M&O budget for consideration. No action was taken.

The Manager made a report of the operations of the District.

A report of the District water situation and availability was presented by the Manager. No action was taken.

Being no further business, the meeting adjourned at 10:45 am.
