The Motion passed.

The Manager submitted a lease agreement with Prosillico Civil for consideration. The lease agreement is for a 2.5 acre temporary construction site located on the District property on the East side of Trevino road and North of the IBWC flood levy. The agreement is for 12 months at \$1,000.00 per month. After a short discussion a motion was made by Levi Burns and seconded by Rick Guerrero to approve the agreement with the changes suggested by the District's attorney. The motion passed.

Bill Moore with Living Way church presented a request to solve the right of way and easement encroachment on lot 4 New Hampshire Commercial Subdivision. The Church is in the process of selling the lot and is trying to clear the title I order to close on time.

The Board entered into an executive session at 9:43 am.

Executive session – Executive closed session pursuant to Texas Government Code, sec. 551.072 – deliberation regarding real estate.

The executive session adjourned at 9:48.

The Board offered to accept \$4,237.55 for the right of way and easement in order to clear the encroachment within the New Hampshire Commercial Subdivision. Mr. Moore agreed to the value and a motion was made by Levi Burns and seconded by Keith Adams to sell the excess right of way and easement to Living Way Church for \$4,237.55. The motion passed.

The manager presented the 2023 M&O budget for consideration. After a review of the proposed budget a motion was made by Levi Burns and seconded by Keith Adams to approve the 2023 M&O budget and to authorize the budgeted wage increases to begin on the first pay period in October 2022. The motion passed.

The Manager made a report of the operations of the District.

A report of the District water situation and availability was presented by the Manager. No action was taken.
