## The Motion passed.

The Lease agreement with Golden Eagle Field Archers was presented for consideration. Kevin Prudhomme, representing the Field archers, asked for a multi-year lease. The Board stated it is reluctant to issue a multi-year lease because of a lease agreement with Ciello Wind Energy for the adjacent property. The energy company has shown an interest in the property leased to Golden Eagle Field Archers for the placement of an underground transmission line. A motion was made by Levi Burns and seconded by Leonard Simmons to continue with the annual lease for 2023 at the 400.00 dollar per year rate. The motion passed.

Permit number 2022-85383659, crossing permit for AEP Texas was presented for consideration. A motion was made by Leonard Simmons and seconded by Rick Guerrero to approve the permit. The motion passed.

Permit number 2023-39536946 for a carport construction for Kathrine Martinez was presented for consideration. Mrs. Martinez is seeking permission to construct a carport that will encroach onto a District easement in the Hick Hill area. The carport will be clear of the existing pipeline and should not interfere with maintenance of the line. A motion was made by Leonard Simmons and seconded by Levi Burns to approve the permit. The motion passed.

A petition from Harlingen Water Works for the purchase of water rights under sub chapter "O" of the Texas water code chapter 49 was presented for consideration. The petition is for the subdivisions recorded in the years 2020-2022 for 250.015 surface acres or 312.59 ac/ft of municipal water rights.. After a short discussion a motion was made by Levi Burns and seconded by Leonard Simmons to accept the petition.

Alan Ozuna gave an update of ongoing legal issues.

Wayne Halbert reported on upcoming legislation.

The Manager made a report of the operations of the District.

The current water allocation report was presented and no action was taken.

Being no further business, the meeting adjourned at 10:30 am.
