A motion was made by Leonard Simmons and seconded by Rick Guerrero to accept the petitions. The motion passed.

An offer from Sam Ruiz of \$7,093.75 for the purchase of .6 acres of District property interest out of block 2 FH Handley subdivision was presented for consideration. A motion was made by Rick Guerrero and seconded by Leonard Simmons to accept the offer and sell the right of way for \$7,093.75 plus attorney and recording fees. The motion passed.

A bid for the sale of District excess equipment (1977 Mac Truck) was presented. A motion was made by Leonard Simmons and seconded by Keith Adams to accept the bid and sell the truck to Dale Roberts for \$2,000.00. The motion passed.

A request from Belia V. Zamora for the relief of penalty and interested charges accumulated on two accounts was presented for consideration.
