The following petitions for exclusion were submitted for acceptance:

1.6 acres Parts of lot 44 and 45 FZ Bishop/ Rice and Taylor Lands (lot 44, 1.484 and lot 45, .116 acres)

Lorenzo Hernandez.

A motion was made by Rick Guerrero and seconded by Leonard Simmons to accept the petition. The motion passed.

A crossing permit for Magic Valley Electric Cooperative was presented for consideration. A motion was made by Levi Burns and seconded by Rick Guerrero to approve the crossing permit number 2021-07860378. The motion passed.

A crossing permit for Texas Gas Service was presented for consideration. A motion was made by Levi Burns and seconded by Leonard Simmons to approve the crossing permit number 2021-34313993. The motion passed.

A Memorandum of Agreement between the International Boundary and Water Commission and Harlingen Irrigation District. Was presented for consideration. The limited ROE is for the sole purpose of allowing the IBWC to construct a flood control structure within the existing IBWC levee easement and the Adams Gardens canal at the flood levee, north of the Adams Gardens River pumping plant. A motion was made by Levi Burns and seconded by Leonard Simons to approve the Memorandum of Agreement. The motion passed.

An Order Setting a Hearing for Exclusions was presented for consideration. A motion was made by Rick Guerrero and seconded by Leonard Simmons to set the date of March 9, 2022 for the Hearing. The motion passed.

A motion to order the 2022 election of two board members for May 7, 2022, in accordance with sections 3.004, 3.005, 3.006, 4.008, 83.010, 85.004, 85.007 Texas Election Code, was made by Leonard Simmons and seconded by Keith Adams the motion passed.

An offer of \$7,500 from the State of Texas to purchase an easement for the construction of a border fence was presented for consideration. The easement is a 50 foot wide .350 acres easement located adjacent to the existing IBWC levee easement and east of Trevino Road on District pumping plant property. A motion to accept the offer and sell the easement was made Leonard Simmons and seconded by Levi Burns. The motion passed.

An offer from Jeff Minor to purchase a .97 acre District Right of Way was presented for consideration. After a short discussion as to the value of the right of way a motion to accept the offer of \$4,432.00 was made by Leonard Simmons and seconded by Rick Guerrero. The motion passed.

The Manager made a report of the operations of the District. Wayne Halbert gave a legislative update and Alan Ozuna gave an update on existing legal matters.

A report of the District water situation and availability was presented by the Manager. No action was taken.

A financial report for FY 2021 was presented for discussion. No action was taken.

Being no further business, the meeting adjourned at 10:30 am.
